Mr. Jerry Barrido appeared before the Board and thanked them for their service to the community. He expressed his concern regarding dogs not being allowed in the Pleasant Dale Park District, and asked if the Board had any suggestions regarding petitions to allow dogs in park areas.

Mr. Davis indicated there were some issues in the past regarding dogs being off leash and other concerns. He noted that service dogs are welcome in the park.

Mr. Gierut pointed out issues regarding extra costs of putting in signage, bag holders, and clean up that would be required.

Mr. Russian offered to have Mr. Barrido contact him to discuss this issue further.

Mr. Russian was given direction to move forward and provide information regarding a new maintenance building. Mr. Russian and Tony Cavazos met with Wight & Company yesterday in a zoom meeting and reviewed drawings and some costs. In March of 2023, the cost estimate of the maintenance facility was roughly \$2.9 million dollars. With his background, Tony Cavazos is very knowledgable with regard to materials that may be needed. He provided some information to Wight & Company, and they can incorporate into their proposal. We might have a proposal for them either in December of this year or January of 2024. Mr. Russian spoke with Tom Reedy regarding bonds. It's important that we don't deplete our savings if the plan is to pay for the new maintenance building with reserve funds. There was a brief discussion regarding grants, heating, and energy savings.
